TAT – The time reported in hours / minutes RSI returns a <u>completed</u> report

- Completed report means all the searches ordered within a "package" of services
- 2. County Criminal searches average 24 hours
- 3. Verification orders 80% return in 48 hours
- 4. Drug Screening
 - Lab based Negative 24-48 hours
 - Lab based Positive 5-7 business days
 - Instant Panels Negative, 15 minutes
 - Instant Panels Positive, 5-7 business days





Causes for delay – County Criminal

- All records found on Nationwide Criminal and Patriot search are verified at the county level (original source) by RSI
- Clerk assisted manual process
 - not enough help at the courthouse
- Natural disasters / illness shut down the courts
- Verification of records, not enough identifiers (RSI reports from 3 PII)
- Automated State loses electronic connection South Carolina and Texas this spring

Court Delays

All Counties, MA: Public access terminals are unavailable. Court clerks have notified their IT team but have not received a restoration ETA. Our researchers will continue to check for updates daily.

All Counties, PA: We are experiencing connectivity issues. Our team is working to resolve these issues. We will provide updates as they are available.






State Issues – criminal searches

- Georgia, Kentucky, Louisiana, Michigan, Texas, West Virginia
 - Clerk assisted
 - 30-50 hours
 - Not entire list...not always a state issue, some states are a mix of automation & clerk assisted
- Michigan / California "Clean Slate Laws" reduce PII
- Mississippi / New Hampshire clerk assisted, huge backlogs, staffing issues
- KY and MISS have an All-Inclusive Statewide report that could reduce TAT.
 - KY \$25 Statewide access fee while most Counties are \$0. Anderson Co. just announced \$27
 - MS \$10 Statewide access fee. Various county fees (7 out of 82) from \$0-\$15

Causes for delay - Verifications

- Employment Verification not on The Work Number, Waiting for employers to return calls
- Education Verification Schools closed
- Reference Checks waiting on reference to return call
- Waiting on Applicant response Need for additional Releases, proof of education, W2
- RSI makes daily attempts to capture all of the above





Causes for delay – Drug Screening

- Applicant slow to respond
- Poor specimen
- Labs closed
- Delivery service (UPS / FedEx) delays
- MRO review
- Natural disasters shut down labs or affect deliveries.





Drug Screening

- Consider Instant Urine Panels return within 15 minutes for negative test
 - Fewer clinic options
- Standard 5-10 Panel's are available
- Custom Panels are available
- All use the same Escreen network and electronic chain of custody forms





Best Practice for Order Entry

Manual Entry

- Review Alias names that auto-populate prior to finalizing order to RSI
 - This will reduce cost
- Double check SSN and DOB
 - Can be reviewed before order is completed

Applicant Entry

- Encourage applicant to use full, legal name
 - Platform does not require middle name, however, very helpful to RSI
 - Some applicants will check the box that says no middle name when in fact the SSN trace will show one
 - Please note that there are risks associated with using the applicant entry service. There could be data entry errors that will cause issues with obtaining an accurate screening report





Best Practice

- Submit Client Compliance Notes to RSI
- Make Sure RSI is aware of any special instructions or compliance request so we can document
 - Criminal Scope reporting
 - Ex: How Many references?
 - Ex: How many attempts to process a verification before calling client or applicant?
 - Ex: How many days to set applicant response to drug screening invitation?
 - Default expiration setting for drug testing invitation is set to 14 days
- RSI post ETA weekly to orders
- RSI also has extended client service hours for help
- Check RSI portal for daily court delay updates





Social Security Trace

- Digital Delve Platform only
- Look for a SSN Trace message

DOB Mismatch found.

No reportable address history found.

SSN was issued before applicants DOB.

A message could indicate some data was entered incorrectly

- SSN should NOT be used for any hiring decision
- If found call RSI at 812-474-9000 to verify Social Security #
- Tazworks platform less errors due to double entry SSN requirement

- Consider Instant Drug Panels for immediate negative responses
